I declare to take on myself any personal responsibility on the nautical qualities of my yacht rigging, crew's capacity security equipment. I also declare to take responsibility of damages caused to third person and to their things or myself and my personal things, at sea or ashore, in consequence of my taking part in the regatta, relieving from any responsibility the Organizing Committee and all people who contribute in the organization under whatever qualification. I am acquainted with the World Sailing - fundamental rule: "it shall be the sole responsible of each yacht to decide whether or not to start or to continue to race".

CONSENT TO THE PROCESSING OF PERSONAL DATA

PRIVACY POLICY PURSUANT ex art. 13 e 14 del Regulation UE n. 679/2016

We inform you pursuant to Regulation UE n. 679/2016 GDPR, that your data will be processed in the following manner for the office press. The data will be communicated to a third party for diffusion of news in the press about the event. The data controller is Yacht Club Lignano Asd – Via M.te Ortigara 3 Lignano Sabbiadoro and the functions inherent to the processing, storage and processing of data provided by article 6 GDPR, are attributed, in compliance with current legislation, with the aid of electronic and in any case automated means.

As a data subject, you have the rights specified in art. 7 Privacy Code and art. 15 GDPR and specifically the right to:

- obtain: the updating, rectification or, where interested therein, integration of the data; b) the deletion, conversion into anonymous form or blocking of data processed unlawfully, including data whose retention is unnecessary for the purposes for which the data were collected or subsequently processed;
